**Refund Policy-** *The student will receive a full refund of all money paid if the student cancels within a three-business-day cancellation period.*

*A student who withdraws or is dismissed after attending at least one class, but before completing 60% of the instruction in the current enrollment period, is entitled to a pro rata refund as follows:*

*As part of this policy, the school may retain a one-time application fee of no more than \$100. The School will make every effort to refund prepaid amounts for books, supplies and other charges. A student will receive the refund within 40 days of the termination date. If a student withdraws after completing 60% of the instruction, and the withdrawal is due to mitigating circumstances beyond the student's control, the school will refund a pro rata amount.*

*A written notice of withdrawal is not required for students receiving funds under Title IV and Title 38, the school will comply with federal guidelines concerning constructive notice of withdrawal. All or a portion of the refund will be used to pay grants, loans, scholarships or other financial aid in conformity with federal and state law. The school will make a "good faith" effort to make a refund, if necessary, by sending certified mail to student's and parent's permanent address.*

In keeping with Vedic traditions and the Ayurvedic sutras, I acknowledge that I have read and understand the Course Catalog and statements below, and that I agree to abide by all rules, guidelines and codes of conduct.

Kanyakumari Ayurveda, LLC, is an educational and healing community. It provides education and limited training but cannot license anyone to practice health care. The certificate presented to eligible students of Kanyakumari, is evidence of satisfactory completion of the course, but does not entitle the holder to any legal right to specific professional practice.

Graduates are expected to share the information they learn in public and individual client settings only to the extent that they are comfortable with their level of knowledge and confident that they are not causing any potential harm by sharing information or explaining something that is beyond their own scope of understanding and safe practice.

Those who graduate at the Certified Ayurveda Practitioner level may incorporate their knowledge and training into any other health care discipline in accordance with that discipline's licensure and regulations. Practitioners not holding a health care license in any licensed discipline should provide therapies under the supervision and direction of a licensed professional. If the health care discipline of primary practice is not statutorily recognized and licensed in the State or jurisdiction of practice, the practitioner should obtain whatever recognition is available in her or his health care discipline by the highest and most widely recognized authority in that health care discipline.

The term Ayurvedic Physician or Doctor, or Vaidya, is reserved for those who have achieved the B.A.M.S. degree conferred on a graduate of a traditional Ayurvedic College in India or those appropriately licensed by the local government authority to use such titles. In Wisconsin, only a licensed MD (Medical Doctor) and DO (Doctor of Osteopathy) may diagnose and treat disease or illness. Therefore, non-licensed practitioners should never diagnose or treat, or use such terminology. Instead, non-licensed Ayurveda Educators and Practitioners may educate about Prakriti and Vikriti and current doshic states, and apply Ayurvedic therapies, but may not diagnose or treat disease or illness.

A student's request for admission into the Year Two plus Internship program is subject to approval by the supervising faculty. There is no obligation on the part of any instructor, faculty or Kanyakumari, to accept any person into the internship, nor automatic acceptance on the basis of any previous or current relationship, study program or enrollment agreement.

Students agree to learn and abide by the requirements of HIPAA (Health Insurance Portability and Accountability Act of 1996) in maintaining the confidentiality of clients' and other students' health information. Students agree not to converse with anyone outside of the Center about any person's health information, nor to communicate with each other about clients or other students' health information in public settings such that confidentiality laws may be breached.

A student has the right to cancel the Payment Agreement and obtain a refund or withdraw from a course after instruction has started and receive a pro-rata refund for the unused portion of the tuition and other refundable charges. If the school cancels or discontinues a course or educational program, the school will make a full refund of all charges. Refunds will be paid within 30 days of cancellation or withdrawal.
